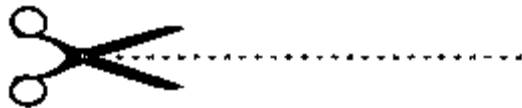
The purpose of the meeting is as follows:

1. To confirm and ratify all action taken by the Board of Trustees throughout the prior year.
2. Election of Trustees.
  - To elect/re-elect 3 trustees to fill the positions of Ken Taylor, Dave Samples and Tom Wuebkenberg – whose terms will expire January 2025.
  - Election of the Trustees will be from candidates nominated by the Nominations Committee or members at the meeting. Each Trustee of the nine-member Board is to serve a three-year term. These newly-elected Trustees’ new terms will end in 2028.
3. To receive, review, and approve reports from the officers and committees of the Board, the annual financial statement of the corporation as prepared by a CPA, and a report to be presented by the General and Deputy Manager on the status of the annual operations.
4. To transact any and all other business which may properly come before this meeting, or any adjournment thereof.
